5. Tower Run – have not heard from RD re: race apps. Hero Half race apps should be at OE. We have Panther Pounce race apps. There is no mail-in app for Tour De Laporte. Registration is online only. The mail in entry that was in the newsletter is only a flyer.

## **Public Relations (Deanna Grimes)**

- 2. We have 2,255 Facebook followers and 537 Junior Strider Facebook followers.
- 3. The Striders have a 15% discount code from Running Warehouse (an online store). We also received free 2 day shipping with the discount code. A discussion followed on whether if we promoted this to our club members, would it be a conflict with Platinum sponsor, Extra Mile. Jose said he would talk to Heather Henderlong about it to get her feedback before the board made a decision.

## **Youth Runner Programs (Beth Boyer)**

- 1. Wrap up track they had 5 people go the USATF meet and 4 people go to the AAU meet
- 2. Pizza party everyone was too busy to get together for the end of track season wrap up pizza party.
- 3. Cross country preview Beth is looking into holding a USATF Grand Prix series. Also looking into offering XC 2k, 3k and 4k race on Oct. 18 and a AAU Qualifier on Nov. 8. She is looking at those dates. We are still in need of a Porter County coach. Looking to the XC practices at Oak Ridge Prairie and Rohrman Park.

### Adult Running Program (Rosa Garcia):

- 1. Rosie has been injured but wants to do a training program for the Hero Half. Beginner runner
- 2. Lory Adams is not being scored for her Gold Cup races. She joined the Striders at the callout meeting for the beginner runner program but later registered for the Gold Cup series at the Public Enemy race. We will discuss this matter the Treasurer and Webmaster to correct her Gold Cup scoring.

### Nominations, Bylaws & Disabled Runners (Tim Brown):

We had two candidates interested in the Treasurer position: Steve Lawson and Dan Koch. Both provided bios with their background information. Tim Brown read each bio to the entire board. A brief discussion followed. Each board member was handed a slip of paper with both names on it. The President opted not to vote and offered to be the tie breaker, if needed. All votes were tallied by the President. There were 4 votes for Steve Lawson and 4 votes for Dan Koch. A brief discussion followed. Because both candidates were outstanding, the board could not decide. The President decided to flip a coin: heads for Steve Lawson and tails for Dan Koch. The coin landed on tails and Dan Koch was appointed as the Treasurer until February 12, 2016.. Both candidates were notified of the outcome.

### Membership and Volunteers (Carri Massau-Ables):
